Remarks

- 1. In principle, 2 interpreters will be required for simultaneous interpretations up to 4 hours and 3 interpreters for longer duration.
- 2. Above rates are calculated based on a portal-to-portal hour scheme, which will also include time spent for prior meetings. Tasks performed outside operating hours (i.e., before 9:00a.m. and after 5:00p.m. for weekdays, and the entire day for Saturdays, Sundays and public holidays) will be charged at 1.5 times of the above rate.
- 3. Above rates are applied on Languages on Mandarin Chinese to English, Cantonese to English, Japanese to English and Korean to English. Other language combination will have different rate.

Cancellation Rates After Exchange of Contracts

Day: working day, except Saturdays, Sundays and public holidays

7 days before interpretation 30%

3 - 6 days before interpretation 50%

2 days before interpretation 70%

Day before/of interpretation 100%

Rates for Prior Meetings (1)

Meetings conducted prior to the date of interpretation will be charged separately at the same rate as in the above table. Although local transportation costs will not be charged in general, actual expenses for transportation to inaccessible locations (e.g., isolated islands) may be charged.

Rates for Prior Meetings (2)

Actual expenses incurred for transportation and accommodation will be charged. There will also be an additional charge for the time lapse before and after the assignment, such as from the time of departure to time when task is executed and that from the completion of the task till interpreter's arrival back home.

Rates for Prior Meetings (3)

In the case when the interpreter arrives a day before or departs a day after the actual day of assignment, an additional charge equivalent to the minimum interpretation charge shown above will be imposed.

In the case when the interpreter arrives or departs on the day of the assignment, additional charges may be required depending on the length of the waiting/travelling time before and after the assignment.
